1. WHO IS THE ADMINISTRATOR?

The administrator of your personal data is RESORT MARKETING Sp. z o.o. with its registered office on

- 2. What kind of your personal data is processed and what for?

Your personal data is processed on the basis of:

- a) art. 6 ust. 1 b of GDPR in order for us to take action upon your request, related to establishing cooperation between you and RESORT MARKETING S. z o.o.
- b) art. 6 ust. 1 c of GDPR in order to fulfill the legal obligation of the Administrator (e.g., accounting regulations and tax regulations)
- c) art. 6 ust. 1 f of GDPR, i.e. for purposes resulting from legitimate interests pursued by the Administrator, consisting of:
- -the organisation and conduction of competitions and promotional campaigns,
- -direct marketing services,
- -archiving documents, including files related to commercial contact, such as portfolios, offers and inquiries, for the purposes of enabling us to establish cooperation with you,
- -pursuing or securing claims,
- -conducting quality analyses and statistics on the services and projects carried out.
- d) art. 6 ust. 1 lit. of GDPR –in other purposes, only if you agree to this (e.g. in order to recruitment)

3. WHO HAS ACCESS TO YOUR PERSONAL DATA?

The recipient of your personal data is the Administrator, its authorised employees and associates, as well as IT administration services, including the hosting service provider and IT systems, employees and collaborators of such entities.

Your personal data will not be processed in the form of profiling (automated decision-making), nor will it be transferred to third parties. If it will be required by law, your personal data can be disclose to authorized entity on the basis of law, including courts and prosecutors.

4. HOW LONG WILL MY DATA BE STORED BY RESORT MARKETING?

- a) personal data processed in order to conclude or perform the contract or fulfill the Administrator's legal obligation will be kept for the duration of the contract, and after its expiry for the period necessary to secure or seek any claims of and related to the Administrator, and will be kept for the period necessary to fulfill the legal obligation of the Administrator (e.g. resulting from tax or accounting regulations);
- b) personal data processed for purposes resulting from legitimate interests pursued by the Administrator will be processed until an objection to such processing has been filed,
- c) personal data processed on the basis of consent will be processed until its cancellation.

5. ENTITLEMENTS

In relation to the fact that we are processing your personal data, you have same rights, presented below.

If you want to use any of them, please contact with us. Then, according to the content of your application:

- a) We provide you confirmation if we processing your personal data or we grant you an access to them. We may also provide you a copy of processed data;
- b) We rectify incorrect data or complement data that are incompleted;
- c) In situation specified by personal data protection law and the scope that is there indicated, we exercise your entitlements to:
- -delate personal data;
- -restriction of processing personal data;
- -transfer personal data;
- -object to the processing of personal data.
- d) If the processing of personal data is based on your declaration of consent, you can withdraw this consent anytime.

We make every effort so that processing of your personal data takes place in a manner consistent with the provisions of law. However, if you belive that we have committed infringemed of the law, You have to right to lodge a complaint with the supervisory authority. (The President of the Office of Competition and Consumer Protection.

- 7. Basic information of personal data security
- 1. The Administrator declares that in applies technical and organisational measures aimed at securing the personal data entrusted tous in accordance with applicable laws.
